

# -OFFICIAL RULES-

## Ultimate Fan Cave Giveaway

**NO PURCHASE NECESSARY TO ENTER TO WIN. A PURCHASE OR ACCOUNT OPENING WILL NOT INCREASE YOUR CHANCES OF WINNING**

### **1. SPONSORS**

The Bulldog Card Ultimate Fan Cave Giveaway (“Giveaway”) is sponsored by Community Choice Credit Union (“Sponsor”), 6163 NW 86th Street, Suite 105, Johnston, IA 50131.

### **2. ELIGIBILITY**

The Giveaway is open only to legal residents of Iowa who are 18 years of age or older at the time of entry. Void outside Iowa and where prohibited or restricted by law. Employees of Sponsor and their immediate family/household members are not eligible.

### **3. AGREEMENT TO OFFICIAL RULES**

Participation in the Giveaway constitutes entrant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning the Giveaway is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein. Visit [www.BulldogAccount.com](http://www.BulldogAccount.com) and open a Bulldog Account Debit Card to automatically receive one (1) standard entry into the Giveaway.

Alternatively, entrants may receive one (1) standard entry in the Giveaway by mailing a 3” x 5” index card with their handwritten full name, mailing address, phone number, birth date and email address. Entries must be mailed to:

winning. No purchase, account opening, or financial transaction is required to enter or win. The Giveaway is void where prohibited by law.

Entrants are required to provide the Sponsor with their legal name, home address, plus a valid, functioning email address (if applicable), and telephone number. By filling out the entry form, all entrants agree that the Sponsor may use their voice, name, photograph, and likeness for promotional purposes without additional compensation, where permitted by law. The Sponsor and their respective directors, officers, and members assume no responsibility for incorrect, invalid, terminated, or non-functioning email or lost, incomplete, late, illegible, or undelivered entries. ## **7. GIVEAWAY ODDS**

The odds of winning depend on the total number of eligible entries received.

## **8. PRIZE DRAWING**

Winners will be selected in a random drawing from among all eligible entries received for the Prize on the applicable drawing date listed above.

## **9. WINNER NOTIFICATION**

Potential winners will be notified via phone and/or email using the contact information on their Bulldog Account or on their mail-in entry form. The potential winner must respond within forty-eight (48) hours of notification and may be required to complete and return an Affidavit of Eligibility, Liability Waiver, and, where lawful, a Publicity Release, as well as provide proof of residency and any necessary tax forms. Failure to respond or comply within the 48 hours will result in disqualification and selection of an alternate winner.

The Sponsor is not responsible for any incorrect or invalid contact information, undeliverable messages, or technical issues that may prevent successful notification.

## **10. GENERAL CONDITIONS**

In the event that the operation, security, or administration of the Giveaway is impaired in any way for any reason, including but not limited to fraud or unauthorized human intervention or other technical problems, or in the event that the Giveaway is unable to run as planned for any other reason, as determined by the Sponsor in their sole discretion, the Sponsor may, in their sole discretion, either a) suspend the Giveaway to address the impairment and then resume the Giveaway in a manner that best conforms to the spirit of these Official Rules or b) award the Prize at random from among the eligible, non-suspect entries received up to the time of the impairment. The Sponsor reserves the right at their sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Giveaway or to be acting in violation of the legitimate operation of the Giveaway. Such activities may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision. Decisions of the Sponsor are final. Sponsor may modify or terminate the Giveaway at any time in the event of circumstances beyond Sponsor's control that impair the integrity or proper functioning of the Giveaway. ## **11. RELEASE AND LIMITATIONS OF LIABILITY**

Giveaway participants agree to release and hold harmless the Sponsor and each of their respective parents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Giveaway, and each of their respective officers, directors, employees, shareholders, representatives, and agents ("Released Parties") from and against any claim or cause of action arising out of participation in the Giveaway or receipt and/or use of the Prize. This includes but is not limited to:

- a) Technical errors associated with the Giveaway, such as lost, interrupted, or unavailable Internet Service Provider (ISP) access, or network, server, wireless service provider, or related connection errors. Said technical errors may also include the unavailability, limited accessibility, or miscommunication of a failed computer, satellite, telephone, cellular tower, or cable transmission line, or a technical failure or jumbled, scrambled, delayed, or misdirected transmission or computer hardware or software malfunction, or failure;
- b) Unauthorized human intervention in the Giveaway;
- c) Mechanical, electronic, human, and printing and/or typographical errors;
- d) Application downloads and/or failures;
- e) Any other errors or problems pertaining to the Giveaway, including, without limitation, errors that may occur in the administration of the Giveaway, the announcement of the winner, the cancellation or postponement of the event, or the incorrect downloading and processing of entries or any Giveaway-related materials;
